- 2. No business was arising from previous year's minutes.
 - 2.1. Motion to confirm previous year's minutes moved by Richard Lord and seconded by Josh Lattimore. Motion carried.
- 3. Ministry Leaders, Parish Council Reports and Incumbent's Report taken as read and received
 - 3.1. Rob spoke briefly to his Rector's report, including 'saints in motion' snapshots. He reminded the meeting of the Key Priorities for 2022-2024: Thriving generations ministry, discipleship pathway, leadership empowerment, local

outreach. Rob highlighted two new projects on the horizon subject to a successful NMDF grant application: Local schools outreach and welcoming refugees. Rob shared stories of 'saints in motion' to encourage thankfulness: "Debra", Camille, "Shane", Yen.

- 4. Matthew Bowditch spoke to the Treasurer's Report & Audited Financials.
 - 4.2. Motion to receive the 2022-2023 Audited Financial Reports, moved by Matthew Bowditch. Seconded by Derek Walter. Motion carried.
 - 4.3. Motion to reappoint auditor Wise Lord & Ferguson for the current financial year, Moved by Matt Bowditch, seconded by Anna Folkerts. Motion carried.
- 5. Presentation of Budget 2023-24 by Matthew Bowditch
- 5.1. Matt acknowledged whilst he is able to present a balanced budget there are challenges ahead to highlight: 1. Funding of Children's & Youth Worker over the next 4 years will need to be met. 2. Estimated Redress Levy (passed at synod this year) could be up to 50% of wellspring's investment type income. Matt acknowledged there are positive opportunities for the year ahead. The Parish Council can apply for just over \$100,000 of NMDF money in the next 3 years. Which could bring with it some exciting ministry opportunities.
- 5.3. Motion to adopt the 2024 Budget as prepared by Treasurer & Parish Council. Moved by Matt Bowditch, and seconded by Derek Walter. Motion carried.
