- 2. Business arising from previous year's minutes:
 - 2.1. Minutes were taken at 2023 AGM and then approved by Parish Council, followed by distribution for any amendment to the wider Parish in anticipation of approval at this year's AGM.
 - 2.2. **Motion:** That the minutes of the 2023 Annual General Meeting be confirmed. Moved by Anna Davy and seconded by Joshua Lattimore. Motion carried.
- 3. Ministry Leaders, Parish Council Reports and Incumbent's Report taken as read and received.
 - 3.1. Rob spoke briefly to his Incumbent's report. He encouraged the meeting in affirming the financial target for mission (2% of income) as identified in the Treasurer's Report.

3.2. John Morse shared an update on the new rector process, explaining progress on Parish Profile, advertising, and Locum arrangements.

- 4.2. **Motion:** That the number of Parish Councillors for 2024-2025 be six. Moved by Philip Thomson and seconded by David McQuillan. Motion carried.
 - 4.2.1. Wardens duly elected, Richard Lord and Anna Folkerts. Rob to make his appointment.
 - 4.2.2. Synod Reps duly elected: Richard Lord and David McQuillan, with Parish Council to fill one vacancy.
- 5. An online election was conducted for four Parish Councillors. Meeting was advised that results would be published in Friday's newsletter.
- 6. Matt Bowditch presented the audited financials for 2023-2024.
- 6.1. **Motion:** Matt Bowditch moved that the audited financials for 2023-2024 be received. Seconded by Wendy Falloon. Motion Carried.
- 7. **Motion:** Matt Bowditch moved to reappoint Auditor Wise Lord & Ferguson for the current financial year 2024-2025, seconded by Gemma Kleywegt. Motion Carried.
 - 7.1. Matt expressed gratitude to Andrew Charles for working with the auditors, answering their questions and consistently keeping detailed and accurate records. Meeting affirmed this thanks.
- 8. Matt Bowditch presented the Budget for 2024-25.
